Enforcement Highlights

Grass/Weed Violations

A reminder that the city "Grass and Weed" violations are enforceable until October 31st. All weeds and grass must be kept under 10 inches on the entire parcel.

Leaf Reminders

We would like to pre-warn residents that they cannot rake leaves awaiting pick-up into the street. Leaves in the street contaminate and clog the stormwater system and can create significant problems. The street sweeper is not in charge of fall leaf pick-up. If you receive a warning letter regarding the

placement of your leaves, please move them to a more suitable location on your property to await pick-up. The Maintenance and Repair department has yet to release the fall pick-up schedule but when available it will appear in the Wilmington News Journal and on the city website.



Basketball Hoop Reminder





As winter approaches, the city asks that you remove your portable basketball hoops out of the street lawn, streets, and sidewalk areas. These hoops can interfere with the snowplow and if damage occurs, the city is not liable.

When in use the hoops can be stored temporarily near the street, but after use they need to be relocated at least one foot behind the sidewalk. Hoops that continue to be a street and sidewalk obstruction will be sent a violation notice. Those hoops that are not removed by the deadline given to the owner, will then be removed by the Maintenance and Repair Department.

August Volunteer Events



Clean-Up Wilmington hosted 2 volunteer events in August. Once again partnering with Wilmington College incoming freshmen, 64 volunteers covered over 4 miles of city streets and removed 12 bags of litter. During the monthly clean-up event on August 26th, 16 volunteers covered 4 miles of downtown streets and alleys and removed 9 bags of trash. The next volunteer clean-up is scheduled for September 23rd at 9am.

Summary of New Finance Items September 7, 2023, Council Meeting

SUPPLEMENTAL APPROPRIATIONS

- a) From the available excess funds of the General Fund to 110.120.5236 "Admin Direct Deductions" the sum of \$61,000.00
- MKV This is to cover the cost of the primary election. We pay for the cost for the city elected officials and also the cost of the municipal court judge race (which was county wide).
- b) From the available excess funds of the Sewer Fund to 635.360.5416 "Sewer Rehab" the sum of \$164,164.40
- Rick Schaffer This will rehabilitate 3,642 feet of sanitary sewer, by applying an interior lining. If we fail to complete this maintenance, the pipe will collapse and replacement will cost five times more money.
- c) From the available excess funds of the Water Fund to 605.350.5214 "Sludge Disposal" the sum of \$405,000.00 Rick Schaffer The principal sludge lagoon at the water treatment plant is at capacity. Annual removal has not kept up with production. The lagoon needs to be fully cleaned out to continue proper treatment of the water and meet EPA requirements.
- d) From the available excess funds of the Retained Hotel Lodging Tax Fund to 292.110.5269 "CRC Grant Program Expense" the sum of \$30,725.00 MKV This increase is due to the increased receipts for the year, which continues to fund the approved grants.
- e) From the available excess funds of the UDAG Revolving Loan Fund to 242.740.5961 "Workforce Program" the sum of \$15,000.00 MKV This is in response to the request from Ruth Brindle and Dessie Rogers for the Workforce Development Director. This is the appropriate fund for this economic development project.
