Enforcement Highlights

Delinquent Tax Submissions



An ongoing department project is to continue to identify vacant land and structures that owe significant amounts of property taxes to the county. This round of submissions to the County Auditor included 8 vacant lots in various areas of the city. These submissions are then shared with

the County Treasurer and County Prosecutor's Offices to evaluate the properties before beginning the foreclosure process. The County Prosecutor's Office is currently working on several vacant properties that are in foreclosure proceedings. Once this process is complete, they will be transferred to the CCRPC/Landbank.

Problem Area Clean-Up

Seasonal Violations & Reminders

Leaves in Street

Reminder to residents not to rake leaves awaiting pick-up into the street. Leaves in the street contaminate and clog the stormwater system and can create significant problems. If you receive a warning letter regarding the placement of your leaves, please

move them to a more suitable location on your property to await pick-up. The Maintenance and Repair department has released the pick-up schedule and it is available on the website.





Basketball Hoops



As winter approaches, the city asks that you remove

your portable basketball hoops out of the street lawn, streets, and sidewalk areas. These hoops can interfere with the snowplow and if damage occurs, the city is not liable.



When in use the hoops can be stored temporarily near the street, but after use they need to be relocated at least one foot behind the sidewalk. Hoops that continue to be a street and sidewalk obstruction will be removed by the Maintenance and Repair

Department. PLEASE NOTE- Beginning in December, basketball hoops that are in the street will be tagged as abandoned property, and if they are not removed by the owner within the specified time frame, the city will remove them.
