Wilmington City Council

January 19, 2023

Wilmington City Council met in regular session on Thursday, January 19, 2023, at 7:30 p.m. at 69 N. South St. Wilmington, Ohio, with President Mark McKay presiding.

CALL TO ORDER

President of Council called the meeting to order at 7:30 p.m.

ROLL CALL

Chief Ron Fithen was present as Sergeant at Arms. Council participated in the Pledge of Allegiance and moment of silence.

PRESIDENT OF COUNCIL

J McKay moved to accept the agenda as presented. B Liermann seconded the motion. Voice vote. Motion passed unanimously.

Agenda accepted as presented.

M Purkey moved to approve the minutes of the January 5, 2023, regular City Council Meeting. B Osborn seconded the motion.

Voice vote. Motion passed unanimously.

President McKay presented Guidelines for Citizen Participation at City Council Meetings as follows:

GUIDELINES FOR CITIZEN PARTICIPATION AT CITY COUNCIL MEETINGS

The Open Meetings Act requires public bodies in Ohio to conduct all public business in open meetings that the public may attend and observe.

The City of Wilmington City Council also provides for a "Public Comment" period during regular council meetings (Wilmington C.O. 111.10 Rule 14).

To ensure City Council meetings remain professional and cordial for council members and visitors alike, members of the public attending Council meetings shall adhere to the following guidelines:

- 1. People who want to speak to Council are asked to sign in prior to or during meeting. When signing in, please include name, address, email address, and discussion topic.
- All speakers must present from the podium and remarks should be directed to City Council as a whole (rather than to any particular member of Council).
 Remarks should not be directed to any member of staff or other audience members. Members of Council and Staff should be referred to by title and/or department.
- 3. Members of the audience may not join City Council discussion from their seats in the audience. If recognized by the President of Council, a member of audience may be invited to speak at the podium during the City Council discussion if the President of Council believes their comments are necessary or helpful for the City Council to continue their discussion or make their decision.
- 4. During the Public Comments portion of the meeting, each speaker is limited to **one period** of **three minutes**. The President of Council or Clerk of Council will notify the speaker when three minutes are up. Meeting attendees may not "donate" their speaking time to another person.
- 5. If the speaker has documents they wish to share with City Council that support their comments, they must present these items to the Clerk of Council for distribution.

- 6. The Public Comments period of the meeting is provided for the public to share information and views, not to engage Council or anyone else in conversations or debate. The three minutes is strictly for the speaker to share their thoughts.
- 7. In many cases, the speaker may be directed to meet with staff to resolve issues or get their questions answered.
- 8. If a speaker's content is deemed disruptive (e.g., demeaning to others, includes profanity, etc.) the President of Council may terminate the person's remaining time immediately.

MAYOR

Mayor Stanforth said the condominium on South Mulberry was beginning. It was noted that the commercial portion of the project will be the first to be constructed, with residential in the next phase. The Mayor announced that SkyEnergy is installing multiple EV charging stations in the downtown area. The cost for installation of the charging stations is 100% covered through AES rebates, with no cost to taxpayer. The elevator project in the City building is underway and should be completed by the end of the next week.

Bryant Mcafee with Omni Fiber gave a presentation on a project that will bring fiber to the premises to residences in the City of Wilmington.

AUDITOR

Auditor Vance said that landfill note legislation will be on the agenda for the next council meeting. Bond counsel is asking for three readings.

SERVICE AND SAFETY DIRECTOR

Public Works Director Rick Schaffer provided an update on the Phase 8 expansion at the city landfill. He explained it will cost approximately \$1 million and will be completed at the end of the summer. The city is currently one year ahead on the expansion schedule due to landfill filling more quickly than expected.

Schaffer provided an update on the Davids Drive construction project. The project is expected to begin in the spring and is funded through ODOT Small Cities and OPWC. During the construction, there will be a single lane of eastbound traffic maintained. The project starts at SR 134 and continues for approximately one mile of Davids Drive.

Schaffer introduced Resolution R-23-04 Expressing intent to sell city surplus items to the public through an on-line auction service and declaring an emergency. He explained this is an annual resolution.
