DECLARING IT NECESSARY TO LIGHT THE STREETS, LANES, ALLEYS, LANDS, SQUARES, AND PUBLIC PLACES IN THE CITY OF WILMINGTON, OHIO, WITH ELECTRIC LIGHTS, AND FOR SPECIAL ASSESSMENTS TO BE LEVIED TO PAY THE COST THEREOF FOR THE YEAR 2011

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILMINGTON, STATE OF OHIO, Three-Fourths of all members elected thereto concurring:

Section 1.That it is necessary to light the streets, lanes, lands, alleys, squares and public places of the City of Wilmington, Ohio, with electric lights in accordance with specifications for the same prepared and recommended by the Director of Public service of said City, which have heretofore been approved, and adopted and ordered filed.

- Section 2. That all of the real estate in said City be and it is hereby declared to be specially benefitted by said lighting as aforesaid.
- Section 3. That the annual cost of said lighting is to be borne by special assessments for the calendar year of 2010, less two percent (2%) thereof, and shall not exceed the sum of One Hundred Ninety Nine Thousand Seven Hundred Dollars (\$199,700.00) annually, which shall be assessed by a percentage of the tax value thereof upon the properties in said City, and the cost of said lighting shall include the expenses of printing and publishing notices, resolutions and ordinances required and all other necessary expenditures incident thereto.
- Section 4. That the assessments so to be levied be paid in equal semi-annual installments due and payable at the same time as general real estate taxes on said lands; provided, however, that the owner of any property assessed may, at his option, pay such an assessment in cash within thirty (30) days after the passage of the assessing ordinances.
- Section 5. That the remainder of the entire cost of said lighting not specially assessed shall be paid by the City out of the General Fund thereof.
- Section 6. That notes of said City of Wilmington may be issued annually in anticipation of collection of assessments as herein provided and in the amount equal thereto upon resolution of Council determining the issuance of such notes to be necessary.
- Section 7. The Clerk of this Council is hereby directed to cause notice of the passage of this resolution to be given in the Wilmington News Journal in accordance with the provisions of Section 727.14, Revised Code.
- Section 8. This resolution shall take effect and be in force from and after the earliest period allowed by law.
