Wilmington City Council met in regular session on Thursday, June 3, 2021 at 7:30 p.m. at 69 N. South St. Wilmington, Ohio with President Mark McKay presiding.

## **CALL TO ORDER**

President of Council called the meeting to order at 7:30 p.m.

#### ROLL CALL

## SERVICE AND SAFETY DIRECTOR

Safety/Service Director B. Shidaker had several items to present.

B. Shidaker stated Rombach Avenue regarding the project. Lanes will begin being closed Friday night and not tonight. Tomorrow you should drive down Rombach because it'll never

be the same. It will be a nighmare after tomorrow. The biggest issue is when they move the poles some of the businesses will be out of power up to a half a day. DP&L is required by law to give businesses advance warning. We have boots on the ground to help. But that is DP&L's responsibility required by law.

Public Works Committee - Chairperson K. Swindler had three items to report.

K. Swindler introduced Resolution No. R-21-23 a Resolution Authorizing the Director of Public Service to Approve the Selection of the Progressive Design-Build Team for the Design and Construction of the New Wastewater Treatment Facilities and Enter into Agreement with Selected Design-Build Team: and Declaring an Emergency

K. Swindler provided an update on the wastewater treatment project and that the project will be awarded in August.

- N. Eveland asked if contractors will be interviewed.
- B. Shidaker stated the City has intervewed three candidates over the past two days. Budget and timeline are important to us, but also longevity and doing things right is the largest project the City of Wilmington has ever had. All three of the programs are well qualified.
- N. Eveland asked if the party selected could come before full Council to discuss their qualifications.

K. Fickert asked that the administration walk Council through the scoring process.

K. Swindler asked that we have second and third reading at our next meeting.

Motion by K. Swindler and seconded by K. Fickertto give first reading on the Resolution by title only.

7 yeas.

The Law Director read the Resolution by title only.

K. Swindler introduced Resolution No. R-21-24 a Resolution Authorizing the Public Service/Safety Director to Apply for, Accept, and Enter Into a Water Pollution Control Loan Fund (WPCLF) Agreement on Behalf of the City of Wilmington for both Design and Construction on Wastewater Treatment Facilities; and Designating a Dedicated Repayment Source for the Loan

Motion by K. Swindler and seconded by M. Snarr to give first reading on the Resolution by title only.

7 yeas.

Motion Passes.

The Law Director read the Resolution by title only.

K. Swindler stated she would like to see second and third reading at our next meeting on R-21-24 at the next meeting.

K. Swindler introduced Ordinance No. O-21-22 an Ordinance amending Section 929.09 – Billing Procedure; Discontinuance for Delinquent Bill, of the Wilmington Codified Ordinances; and Declaring an Emergency

Motion by K. Swindler and seconded by M. Snarr to give first reading on the Ordinance by title only.

7 yeas.

Motion Passes.

The Law Director read the Ordinance by title only.

K. Swindler stated she would like to see second and third reading at our next meeting on O-21-22 at the next meeting.

K. Swindler also provided a few brief updates regarding Burtonville reservoir which appears to be on schedule and will be completed in November. K. Swindler also provided a brief update on the Federal litigation related to PFAS. Almost all PFAS is out of the City of Wilmington's water supply which is approximately \$200,000.00 a year. K. Swindler stated the airpark had an incident with a contained spill which was a great opportunitity to identify a better process and have better inroads to pull together community resources to get first and immediate notification if there are any spills like this. The spill did not impact the water supply. There was a significant watermain break on Trusdale last week and our water plant facility operated at full capacity for two days.

Solid Waste/Recycling Committee- Chairperson J. McKay had no items to report.

## REPORTS TO COUNCIL

N. Eveland asked question on Covid relief fund dollars and Additional America Relief Funds in the future. Auditor Vance provided a brief update on how the allocation of funds and expenditures can move forward.

Motion by B. Liermann and seconded by N. Eveland to approve the Auditor Treasurers Report Income Tax Report as presented.

7 yeas.

- J. McKay wanted to compliment everyone at the cemetery for Memorial Day and how great the celebration was earlier this week. J. McKay gave a shoutout on that.
- B. Liermann complimented Mayor Stanforth for his tribute.
- N. Eveland spoke regarding storm water fee increases beginning in July. The administration answered his concerns on when people have concerns about how they are being assessed for their square footage for the impervious surface areas regarding decks and other small sheds which are included in calculation. N. Eveland encouraged people to go to stormwaterwilmington.com where there is an appeals process to attempt to review if they have concerns. There is then a review at Board of Control. There is an appeal and due process that people who has concerns about how their assessment is being calculated.
