COUNCIL March 4th, 2021

Wilmington City Council met in regular session on Thursday, March 4th, 2020 at 7:30 p.m. Virtually on Zoom with President Mark McKay presiding.

CALL TO ORDER

President of Council called the meeting to order at 7:30 p.m.

ROLL CALL

Council participated in the Pledge of Allegiance and moment of silence.

MAYOR

Mayor Stanforth spoke regarding the ODNR Officer Jason Lagore who passed away recently. Wilmington began adding fluoride to the water last week. There is a Community Blood Drive moving forward. St. Columbkille will have a Fish Fry tomorrow from 4:30-7pm on Friday's during lent.

AUDITOR

SERVICE AND SAFETY DIRECTOR

- B. Shidaker spoke regarding the passing of ODNR Officer Lagore.
- B. Shidaker provided an update on the South South Street and Sugartree intersection and traffic safety devices.
- B. Shidaker stated a resolution for Rombach Avenue Grant funding will be before council at the next council meeting and he will be asking for three readings. There will not be access for up to 15-20 minutes in certain segements, but it will occur infrequently. There may be lane restrictions, but than a 15-20 minute segment when the mill is going past one time. There will be lane restrictions and work will begin in June.

City Services Committee - Chairman N. Eveland had several items to present.

- N. Eveland brought discussion regarding cemetery funding and possible levy. Committee discussed last week and discussed the desire to move forward to placing the issue on the ballot for 1 mill on the November 2021 ballot.
- J. McKay brought forward the idea to upgrade to column barium. That is a significant cost. There is a lot of deffered maintenance where we have trees that need trimmed, paving that needs to be done, bridges replaces, or other infrastructure items decaying. The Trustees of the cemetery didn't have the funds to deal with this. If we were to approve this to go to the voters, the cemetery would be in good shape for a long time and hopefully, never need to have another levy. I check with townships and they don't maintain them with General Fund Dollars. I hate going to the voters. We didn't ask for the cemetery and were required to take care of it under Ohio Law. Brian Shidaker has done an excellent job handling the funds we were given and stretching them out. We didn't think those funds would be able to last this long. We do an excellent job with the limited resources.
- B. Liermann we can't keep kicking the can down the road and we need to provide transparency. We need to let people know how funds are utilized and we don't need to continue digging a hole. 1 mill is the right way to go.
- N. Eveland said there are state grants for cemeteries that maybe we can look into. We have to address this and it's a \$150,000.00 question we will have to address.
- M. Snarr stated he doesn't know how it became our responsibility and asked if someone could clarify this.
- B. Shidaker stated by default if a cemetery association cannot take care of it, we are required by law to take it over. The Ohio Revised Code in 2015 required us to take it over. It wasn't solvent back then and it isn't solvent now. I have a bias for our cemetery because ¾ of my grandparents are buried there. Nothing get's purchased at the cemetery without my approval. Without additional funding, this property is not going to be solvent. Some plots were purchased for \$5 and \$10 and that is not enough money to take care of property. Anyone who wants to see expenses at cemetery, I will gladly share.
- J. McKay stated we have potential for growth there. We aren't totally landlocked. There is potential for expansion.
- M. Purkey asked how much longer do we anticipate the cemetery to operate without expansion.
- B. Shidaker stated fifteen years, but we could expand to give us an extended life. The real value is in the land to the west.
- N. Eveland wanted other members to think this over and how to proceed.
